I would first and foremost like to thank you for your letter explaining your current sentence at the Ohio State Penitentiary, and providing my office with reference to your Parole Board record. I am well aware of the implications of SB2 and the injustices that the Bill has created for offenders, such as yourself, that were sentenced under "old law," or indefinite terms, and are now serving disproportionate sentences.

Secondly, before we attempt to aid any disparities, I will need to know the conditions of your nine year gun specification offense. Why are you serving nine years on gun specifications when, even under "new law," consecutively served charges would not add up to a nine year term?

Furthermore, you must understand that many offenders share your same conviction. Why do you feel that your situation above others warrants help? I look forward to hearing from you.
